 - Jan. 2016 = 25% increase to employee HSA annual contribution

 - o R. Mello outlined the two options available regarding SLOs:
 - File a local grievance as a district
 - NEARI files a declaratory suit to challenge the interpretation of the law on behalf of all districts involved in RI
 - Members are encouraged to speak to their building reps. regarding the two options outlined above
 - o Conversations with NEARI uniserve/ lawyers and rep. council suggest allowing NEARI to handle the suit at the state level is in the best interest for BWEA members.
